## Mt. Juliet Senior Center Rules and Regulations

Revised November 4, 2010

The purpose of the center is to provide place for seniors aged 55 and older to gather for recreation, social, wellness and education programs at no or low cost.

Members, guests and staff shall treat each other with respect and courtesy at all times. The following are rules and guidelines for conduct required by all participants of the center.

- 1) Obey the golden rule: "Treat others as you would like to be treated".
- 2) Only products or services that benefit the center can be sold on the premises.
- 3) Anyone under the influence of drugs or alcohol will not be allowed on the premises.
- 4) Firearms are not allowed on the premises except by law enforcement.
- 5) Smoking is allowed only in designated areas. THIS IS A SMOKE FREE FACILITY.
- 6) Gambling, vandalism, loud and disorderly conduct is not permitted on the premises.
- 7) Equipment, tools, supplies or any property of the center may not be removed from the premises without the permission of the Executive Director or Board Chairman.
- 8) This is an older adult facility. Children should not be in the building unless supervised or unless the scheduled program is for "families".
- 9) Inappropriate behavior such as creating a disturbance, interrupting programs or using foul language will not be tolerated.

Failure to comply with these rules and regulations will result in termination of membership and exclusion from the premises.
