Basic Guidelines for Membership

1. Obey the Golden Rule: "Treat others as you would like to be treated."
2. Members and Guest must "sign in" when entering the building and "sign out" upon exiting the building.
3. Only products or services that benefit the Center can be sold on the premises with advanced permission.
4. Anyone under the influence of drugs or alcohol will not be allowed on the premises.
5. THIS IS A SMOKE FREE FACILITY. Smoking is allowed only in designated areas.
6. Gambling, vandalism, and/or loud and disorderly conduct are not permitted on the premises.
7. Equipment, tools, supplies, or any property of the Center may not be removed from the premises without the permission of the Executive Director or Board Chairman.
8. This is an older adult facility. Children should not be in the building unless supervised or unless the scheduled program is of "families".
9. Inappropriate behavior (creating a disturbance, interrupting programs, using foul language, etc.) will not be tolerated. The appropriateness of member behavior shall be set by Center Staff.
10. Bullying by any member towards another member or staff will not be tolerated. You will face disciplinary action, up to being removed as a member.

Failure to comply with these basic rules and regulations and others listed in the Membership Guideline Booklet will result in termination of membership and exclusion from the premises.
